prior to said meeting and to everyone in attendance at said meeting who requested a copy:

RESOLUTION declaring the intention to issue \$6,500,000 Working Cash Fund Bonds of Thornton Fractional Township High School District Number 215, Cook County, Illinois, for the purpose of increasing the Working Cash Fund of said School District, and directing that notice of such intention be published in the manner provided by law.

\* \* \*

WHEREAS, pursuant to the provisions of Article 20 of the School Code of the State of Illinois, and all laws amendatory thereof and supplementary thereto (the "Code"), a fund to be known as a Working Cash Fund (the "Fund") may be created and maintained in and for Thornton Fractional Township High School District Number 215, Cook County, Illinois (the "District"), in the manner prescribed in the Code, for the purpose of enabling the District to have in its treasury at all time sufficient money to meet demands thereon for expenditures for corporate purposes; and

WHEREAS, the District has heretofore created and maintained such Fund in the manner prescribed by the Code; and

WHEREAS, under the provisions of the Code, the Board of Education of the District (the "Board") is authorized to incur an indebtedness and issue bonds as evidence thereof (the "Bonds") for the purpose of increasing the Fund; and

WHEREAS, the Board has determined and does hereby determine that it is advisable, necessary and in the best interests of the District that the Fund be increased and that the District incur an indebtedness and issue Bonds as evidence thereof in the amount of \$6,500,000 for said purpose; and

WHEREAS, before such Bonds may be issued for said purpose, the Board must adopt a resolution declaring its intention to issue such Bonds for said purpose and direct that notice of such intention be published as provided by law:

NOW, THEREFORE, Be It and It Is Hereby Resolved by the Board of Education of Thornton Fractional Township High School District Number 215, Cook County, Illinois, as follows:

Section 1. Incorporation of Preambles. The Board hereby finds that all of the recitals contained in the preambles to this Resolution are full, true and correct and does incorporate them into this Resolution by this reference.

Section 2. Declaration of Intent. The Board hereby declares its intention to avail of the provisions of the Code, and to issue Bonds in the amount of \$6,500,000 for the purpose of increasing the Fund and enabling the District to have in its treasury at all time sufficient money to meet demands thereon for expenditures for corporate purposes.

Section 3. Notice of Intent. In accordance with the provisions of Section 5 of the Local Government Debt Reform Act of the State of Illinois, as amended, notice of said intention to avail of the provisions of Article 20 of the Code and to issue Bonds for the purpose of increasing the Fund shall be given by publication of such notice at least once in the *Chicago Sun-Times*, the same being a newspaper of general circulation in the District.

Section 4. Form of Notice. The notice of intention to issue the Bonds shall be in substantially the following form:

# NOTICE OF INTENTION OF THORNTON FRACTIONAL TOWNSHIP HIGH SCHOOL DISTRICT NUMBER 215, COOK COUNTY, ILLINOIS TO ISSUE \$6,500,000 WORKING CASH FUND BONDS

PUBLIC NOTICE is hereby given that on the 22nd day of September, 2020, the Board of Education (the "Board") of Thornton Fractional Township High School District Number 215, Cook County, Illinois (the "District"), adopted a resolution declaring its intention and determination to issue bonds in the aggregate amount of \$6,500,000 for the purpose of increasing the Working Cash Fund of the District, and it is the intention of the Board to avail of the provisions of Article 20 of the School Code of the State of Illinois, and all laws amendatory thereof and supplementary thereto, and to issue said bonds for the purpose of increasing said Working Cash Fund. Said Working Cash Fund is to be maintained in accordance with the provisions of said Article and shall be used for the purpose of enabling the District to have in its treasury at all time sufficient money to meet demands thereon for expenditures for corporate purposes.

A petition may be filed with the Secretary of the Board (the "Secretary") within thirty (30) days after the date of publication of this notice, signed by not less than 3,950 voters of the District, said number of voters being equal to ten percent (10%) of the registered voters of the District, requesting that the proposition to issue said bonds as authorized by the provisions of said Article 20 be submitted to the voters of the District. If such petition is filed with the Secretary within thirty (30) days after the date of publication of this notice, an election on the proposition to issue said bonds shall be held on the 23rd day of February, 2021, unless none of the voters of the District are scheduled to cast votes for any candidates for nomination for, election to or retention in public office at said election, in which case an election on the proposition to issue said bonds shall be held on the 6th day of April, 2021. The Circuit Court may declare that an emergency referendum should be held prior to either of said election dates pursuant to the provisions of Section 2A-1.4 of

the Election Code of the State of Illinois, as amended. If no such petition is filed within said thirty (30) day period, then the District shall thereafter be authorized to issue said bonds for the purpose hereinabove provided.

#### **Options**

Recommendations: Two possible "Options" based upon the guidance from the Illinois Department of Public Health (IDPH).

#### • Option 1-Hybrid Plan:

- Students attend school in-person for 1-2 days per week and are at home for remote learning for the remaining days of the week.
- In-person class sizes will be limited to half of a class of students to ensure social distancing between students.
- o Students and staff will be required to wear masks.
- Students will have their temperatures checked every day upon arrival at school. If temperature is above 100.4°F, students will be sent home.

#### Guiding Principles of the Hybrid Learning Design:

- Focus on a Safe and Healthy Learning Environment
  - o Prioritizing social distancing and safety guidelines from the Illinois State Board of Education.
  - Every Wednesday is dedicated to deep cleaning
- Focus on Equity
  - Ensuring access and equity for all students
- Focus on Quality Instruction
  - Students will have an opportunity to attend 1-2 days of in-person instruction with a percentage of the class in order to focus on small group instruction.
  - Students will have an opportunity to receive small group instruction during remote learning days (break-out rooms)
  - Students will have an opportunity to receive synchronous and asynchronous instruction during remote learning days. Guiding Principles of the Hybrid Learning Design:
- Focus on Social Emotional Learning
  - o Students will receive daily social emotional lesson from our District Curriculum
  - $\circ$  Students will have an opportunity to attend 1-2 days of in-person instruction with
  - a percentage of the class in order to focus on small group instruction.

- Students will have an opportunity to receive small group instruction during remote learning days
- Students will have an opportunity to receive synchronous and asynchronous instruction during remote learning days.

#### • Option 2-Fully Remote:

- o All students will be fully remote with the teachers having the option to instruct students on-site at the school or remote, based upon guidance from IDPH and Illinois School Board of Education (ISBE)
- Students will be required to attend virtual classes daily based on guidelines
- o Synchronous, 5 days a week instruction using the Wednesday alternative schedule
- o One day of Professional Development alternating between department and district/building time from 2-3:15 pm and autonomous teacher planning time while the PPS and Deans Offices provide SEL services (TBD) from 1:45-3:15 on the remaining 4 days.
- Apex Learning would be used as a resource for all teachers; especially for teachers that need to alter their traditional course, i.e., choir, band, art.

#### Thornton Fractional School District 215 and Village of Lynwood Police Department 2020-2021

#### Reciprocal Crime Reporting Agreement

The Village of Lynwood, Illinois Police Department and the Thornton Fractional School District 215 wish to enter into an agreement of reciprocal crime reporting in accordance with the laws of the State of Illinois.

The presence and introduction of criminal activity within the school setting represents a threat to the orderly flow of the educational process and the peace and safety of those within that setting.

Therefore, in response to the public interest and the legislative requirements, the undersigned agree to the following protocols as they pertain to the reporting of actual and suspected criminal activity involving students and personnel of the Thornton Fractional School District 215.

- The Superintendent of Thornton Fractional School District 215 and the Chief of Police of the Village of Lynwood Police Department will arrange periodic meetings, as needed between the school and the police department officials. Said meetings shall be intended and designed to improve general communication between the parties and share information relevant to criminal activity affecting education and the community.
- Law enforcement officials designated by the Chief of Police of the Village of Lynwood Police Department and District personnel designated by the Superintendent of District 215 shall report to each other concerning the following types of activities when such activity involves students or employees of the District.
  - A. All incidents involving illegal or controlled substances or look-a-like substances.
  - B. All incidents involving possession or use of weapons or any instrument used as a weapon.
  - C. All incidents involving possession, use or distribution of Cannabis or a looka-like.
  - D. All incidents involving a forcible felony or other serious crime.

This agreement may be terminated by one party without affecting the obligations of the remaining parties. The agreement shall be effective upon authorized signatures of the respective parties.


The Village of Lansing, Illinois Police Department and the Thornton Fractional School District 215 wish to enter into an agreement of reciprocal crime reporting in accordance with the laws of the State of Illinois.

The presence and introduction of criminal activity within the school setting represents a threat to the orderly flow of the educational process and the peace and safety of those within that setting.

Therefore, in response to the public interest and the legislative requirements, the undersigned agree to the following protocols as they pertain to the reporting of actual and suspected criminal activity involving students and personnel of the Thornton Fractional School District 215.

- 1. The Superintendent of Thornton Fractional School District 215 and the Chief of Police of the Village of Lansing Police Department will arrange periodic meetings, as needed between the school and the police department officials. Said meetings shall be intended and designed to improve general communication between the parties and share information relevant to criminal activity affecting education and the community.
- 2. Law enforcement officials designated by the Chief of Police of the Village of Lansing Police Department and District personnel designated by the Superintendent of District 215 shall report to each other concerning the following types of activities when such activity involves students or employees of the District.
  - A. All incidents involving illegal or controlled substances or look-a-like substances.
  - B. All incidents involving possession or use of weapons or any instrument used as a weapon.
  - C. All incidents involving possession, use or distribution of Cannabis or a looka-like.
  - D. All incidents involving a forcible felony or other serious crime.

This agreement may be terminated by one party without affecting the obligations of the remaining parties.
