

THE MARK DeVRIES MEMORIAL SCHOLARSHIP

This scholarship program was established by the widow and son of Mark DeVries as a way to honor Mark, who exemplified the “all-around nice guy” on campus. Mark demonstrated good character, strong leadership, athleticism, citizenship, friendship, and commitment to academics and community. Mark was a 1982 graduate of T.F. South High School and was involved in Choir, Drama, National Honor Society, football, and basketball. Mark had a successful career as a financial advisor but measured his success in the relationships he developed over his lifetime. He was deeply committed to the betterment of his community and the enrichment of the lives of those he came in contact with daily. He was a lifetime resident of the region and passed away in August, 2017.

PURPOSE

The intent of this scholarship is to aid financial assistance to a member of the senior graduating class of T.F. South High School. Such monies, designated by Karin DeVries, widow of Mark DeVries, have been established to assist a graduate who has been accepted by and enrolled with an accredited college, university or trade school.

ELIGIBILITY

Applicant must reside within the established boundaries of Thornton Fractional Township South High School. The applicant must have attended T.F. South High School all four years (and must have maintained a 3.0 GPA all four years). Applicant must have played a minimum of one sport all four years of high school with at least two years as a varsity player, and have participated in a minimum of one other extra-curricular, non-sport related program. Applicant must provide one letter of recommendation from a faculty member indicating how they are considered a leader among their peers. A student may receive this scholarship once, per lifetime.

Scholarship Grant

This award is privately financed by monies secured by a portion of the estate of Mark DeVries, his widow, Karin DeVries, being the primary beneficiary agent. The fund is administered by the Athletics Office of Thornton Fractional South High School, located at 18500 Burnham Avenue, Lansing, Illinois. An annual report of the receipts, expenditures, interest earned, etc., shall be made available for inspection.

The amount of the award is to be determined on an annual basis and may be used for expenses related to enrollment in an institution of higher learning. Currently, one student-athlete, annually, will be awarded the amount of \$1000.00. Disbursements will be made upon receipt of a current

enrolment verification certificate, the first grading period transcript indicating good standing, of an applicant.

SCHOLARSHIP COMMITTEE

The committee designated to oversee the execution of this scholarship shall consist of the following members: Karin DeVries, (widow of Mark DeVries), the principal of T.F. South High School, and the assistant to the principal of T.F. South High School, along with a rotating member of the DeVries family (at their discretion). In the event any of the listed members cease to exist or no other members are available or unable to be located, the appointment of the vacancies, to the committee, shall be filled as a joint venture, of the remaining participants.

METHOD OF SELECTION

The selection and decision-making process, of this governing committee, shall be final. Awarding of the scholarship shall be based upon the criteria established within the application and the information submitted by each applicant.
